## IRP TAG REGISTRATION Renewal Info

DOT (MCS-150) Update:  
We recommend updating yearly, required every other year.

Corporate Registration:  
Due before April 1st each year

Drug and Alcohol Consortium:  
On your anniversary date each year

IFTA License & Decal Renewal:  
December 31st each year

Unified Carrier Registration (UCR):  
December 31st each year

New Mexico Permit:  
December 31st each year

New York Permit:  
December 31st every 3 years  
(Expiration Years: 2021, 2024, 2027, 2030 cont.)

Kentucky Inventory Report:  
December 31st each year

### HEAVY HIGHWAY VEHICLE USE TAX 2290's

2290's are effective, July - June of each year. Due to be renewed July of each year. If vehicles are newly purchased you'll pay prorated (cheaper) rates to the IRS. Normal renewals you'll pay full year rates to the IRS. All rates are based on the total GVW of your tractor + trailer + max load.

1st Quarter Tax Return:  
(January, February, March)  
**Due: April 30th**

2nd Quarter Tax Return:  
(April, May, June)  
**Due: July 31st**

3rd Quarter Tax Return:  
(July, August, September)  
**Due: October 31st**

4th Quarter Tax Return  
(October, November, December)  
**Due: January 31st**

**All filings and payments are due prior to the end of the month due or you will automatically be charged a late fee first day of the following month.**

### MINIMUM LEGAL REQUIREMENTS

Georgia Transport Compliance will need your odometer readings & legitimate fuel receipts showing state & gallons purchased in order to calculate your fuel tax. If you have electronic logging devices for fuel and/or miles, we can use that for fuel taxes as well.

All dates are state regulated. In order to have them submitted ON TIME without penalties, you MUST turn them into GTC in a timely manner.

From the date your IFTA license is applied for & goes into effect is the quarter you MUST begin filing!

We will NOT accept BOL's as a form of miles submission effective January 2020

To figure out your IRP tag expiration month you look at what name the IRP tag is registered under. Company name it's the first letter of the first word. Personal name it's the first letter of your last name. Expiration months are below.

A-B	1/31	12/31
C-D	2/28	1/31

S-T	10/31	9/30
UVW	11/30	10/31
XYZ	12/31	11/30

**EXAMPLE:** If your IRP tag expires 7/31, the state wants your tag renewal to be filed 1-2 months prior, so file between 5/1 and 6/30. If filed on time, they won't charge you late filing fee's. You won't have to pay tag renewal fee until the 15th of tag expiration month so 7/15, no later than the end of expiration month. It will usually take 7-14 business days to receive new cab card and decal for plate in mail from day of payment.

We will provide checklists for most IRP services you will need from us.

**GVW is the Gross Vehicle Weight of your truck.  
Tractor lbs. + Trailer lbs. + Max Load lbs. = GVW**
